#### **RIDE COURT ACTIONS WORK PLAN**

### Court Action #1: Revise/Redesign Career Development Plan

Redesign the CDP to focus less on descriptive baseline and more on developing and targeting a specific career path for each student through 3 phases of A.) Discovery (breadth of experience), B.) paid employment experiences in one or two targeted areas and C.) actual job creation and development.

Revise CDP to guide individuals from discovery to targeted work trials to job search and job development.

**DUE DATE: JULY 2023** 

**History:** The CDP has been in use since 2014. Currently all youth in the transition target population maintain a CDP and RI schools have met the compliance requirements of the CDP for several years. Funding has been maintained to provide significant training and ongoing professional coaching since 2014. The redesign of the CDP will now shift to the approach that the court monitor has cited in the August 2022 recommendations and the December 2022 court actions.

Court Action #2: Refocus career planning and placements to develop paid employment while still in school with the goal of each student having a paid job before exiting school

Every student has a continuing job in an integrated setting at the time of school exit. With paid employment in school and a job at school exit as the goal, the state needs to provide targeted TA and additional resources to individuals, families, and schools towards that end.

#### DATE DUE: SEPTEMBER 2023

History: The CDP has captured student's general interests, preferences, skills, and abilities that have supported career exploration, integrated trial work and summer work experiences. Job development & job coaching services in the last year prior to exit was not a consistent practice that was being implemented in schools as noted in the Monitor's recommendations. Additional resources and funds to conduct job development and placement for individual students is a recommendation that RIDE will support ORS and BHDDH in implementing.

**Court Action #3:** Include community activity in transition planning with the goal of each student having three or four active community connections before exiting school.

Every student exits school with a number of established relationships with community organizations and activities. The State needs to develop a strategy for providing braided funding to districts for that purpose.

**History:** Many students may have community connections based on various school relationships/connections with organizations (YMCA, libraries, etc) but may be more whole class oriented events rather than connections created for an individual student.

**Court Action #4:** Provide funding from ORS and BHDDH directly to school districts to increase schools' capacity to develop employment and community connections. Using vendors or school districts as vendors for ORS funding, increase the number of youth in transition who have paid summer employment.

Additional resources provided to individual students to supplement school funding (for developing employment and community connections). The State needs to develop a funding stream for all youth found eligible for DD Services for purpose above to be included in 2024 Budget Cycle. Specifically, Monitor recommends that ORS and BHDDH provide funding for each/every student for job development and job coaching during the last 2 years before exiting. Monitor recommends that BHDDH provide funding for each/every eligible student for community planning and for developing community relationships.

**Court Action #6:** In response to family requests, provide every family with a consistent person to talk to and to serve as a guide through the transition process. Provide every school district with funding for stipends for family mentors.

Providing families with a consistent person to talk to and to serve as a guide through the process. Given that family expectations are the other significant predictor of post school employment, reaching families earlier and more consistently is a key factor in increasing employment outcomes.

**DUE DATE: MARCH 2023** 

**History:** RIDE, ORS and DD have provided statewide, regional and local support to families regarding the introduction of state services. ORS has an assigned counselor to each high school and DD assigns social workers in the student's last year of exit to support families in transitioning to adult services. RIDE and DD also have contracts with agencies that support families. The model that the court monitor currently recommends is not in place.

Court Action #7: Increase access and use of Career and Technical Education by youth in transition.

Increasing access to CTE both as a strategy for discovery and as a path to an actual job. The State should track and report the number of students with IDD who participate in CTE.

**DUE DATE: JULY 2023** 

**History:** Many classrooms that support students with IDD have strong connections to CTE programming, affording students career exploration activities, school enterprise programs, and skill building opportunities. Participation for these students is not collected through the standard CTE data collection. RIDE will work with LEAs to foster increased access and involvement with CTE programming for students with IDD for discovery, skill development and career path development opportunities.

**Court Action #8:** Develop a strategy for increasing access of youth in transition to transportation to employment and community activities.

The Monitor recommends that the State meet with each district to identify transportation issues and develop solutions. The main issue in rural areas is a lack of public transportation. The main issue in suburban/urban areas is the need for more mobility training.

## **DUE DATE: JULY 2023**

History: Many school districts use district vans, school bus or public transportation (RIPTA, RIDE) to access student community and employment activities. However, lack of public transportation in rural areas has been a longstanding barrier. Many students

have been supported through ORS for travel training and the Teachers of Life Skills network have access to and implemented a travel training curriculum.
